FRIDAY & SATURDAY & SUNDAY OPEN & NOVICE WALK-THRUS - All Open Stdl walk, run / all Novice Std walk, run all Open JWW walk,run / all Novice JWW walk, run

MEASURING: There will be a VMO at this trial.

Each dog must have an official Jump Height Card OR a yellow Temporary Measurement Form prior to running any of the agility courses. Each dog 15 months to 2 years old must have permanent AKC Jump Height card or 1 Temporary Measurement form. Each dog 2 years of age or older must have an official jump height card or 2 yellow Temporary Measurement Forms (measurements done at 2 years of age or older) If you do not have the required official measurement card or temporary form(s), your dog MUST be measured by one of the judges prior to running. The measurement done before your first run will be effective for the rest of the weekend. It is the owner's responsibility to have his/her dog measured prior to running the courses. **MEASURING** will take place approximately 30 minutes prior to briefing and walk-thrus for each class.

MOVE-UPS

Move-ups prior to a set of trials. Dogs shall be moved up to higher class at the request of the owner, as a result of qualifying for agility title, provided that the request is made in writing to Trial Secretary **no later than 6:00 p.m. on Monday, June 25, 2017.**

Dogs who qualify for higher class by earning a title on Saturday may be moved up for the following day if the request is received in writing before end of that day's trial. All correspondence will be answered and acknowledgement sent of receipt of all move-ups and corrections to entries.

WAIT LISTS

To fill openings created by entries withdrawn prior to date & time established by the club. Such date may be beyond the event closing date; however, it must be a minimum of three (3) days prior to first trial date of the set of trials. All entries must be received prior to the closing date and time.

The club must establish a maximum number of entries that may be placed on the wait list. Whether club is offering a wait list, how many entries are being accepted on the wait list and the closing date/time of wait list must be published in trial's premium list. A full refund is to be reimbursed to any entrant whose entry is replaced by wait-listed entry.

Everett Turnpike North to Manchester I-293/101 West. Follow signs towards Rt 101 West (Bedford-Milford).

AK9C is located on Rt. 101, approximately 6 miles from the Rt. 114 interchange.

AK9C is on the right across from Camp Road at the blinking yellow light.

FROM THE SOUTH (Boston)

North to Manchester I-293 to 101 West.

Follow signs towards 101 West (Bedford-Milford). AK9C is on the right across from Camp Road at the blinking yellow light.

FROM THE NORTH (Concord)

South to I-293 towards 101 West. Follow signs towards 101 West (Bedford-Milford).

AK9C is on the right across from Camp Road at the blinking yellow light.

FROM THE EAST COAST

West towards Manchester/Bedford. Follow Rt. 101 West (Bedford-Milford) AK9C is located on Rt. 101, approximately 6 miles from the Rt. 114 interchange. AK9C is on the right across from Camp Road at the blinking yellow light.

FROM THE WEST

101 East towards Manchester/Bedford. Watch for Salzburg Square Shopping Complex. AK9C is approximately 1 mile on the left, passed Salzburg Square, across from Camp Road at blinking yellow light
