MEASURING: There will not be a VMO at this trial.

Each dog must have an official Jump Height Card OR a yellow Temporary Measurement Form prior to running any of the agility courses. Each dog 15 months to 2 years old must have permanent AKC Jump Height card or 1 Temporary Measurement form. Each dog 2 years of age or older must have an official jump height card or 2 yellow Temporary Measurement Forms (measurements done at 2 years of age or older) If you do not have the required official measurement card or temporary form(s), your dog MUST be measured by one of the judges prior to running. It is the owner's responsibility to have his/her dog measured prior to running the courses.

MEASURING will take place approximately 30 minutes prior to briefing and walk-thrus for each class.
