SET-UP: CRATING space is VERY limited. X-Pens are not allowed. Crating in the lobby and small crating room off the lobby. Crates to be stacked when possible. There is no floor space for crates for unentered dogs. Dogs must always be in crates except when in ring or at practice jump. No exhibitor chairs - facility has chairs available. Chairs allowed in crating area if there is enough room for all crates. Aisles must always be clear as per Fire Department regulations.

POTTY AREA is grassy strip in front of building & pebble stone potty area in front of loading bay. Neighboring complexes are not to be used for exercising your dog, parking and/or training. Any exhibitor in violation of this rule will be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Dogs are always to remain on leash during trial hours except when in the ring or at the practice jump. On leash includes all of Fifth Industrial Court including those areas by Essco and Broadway Dairy. Neighboring complexes directly across from Doggie U are not to be used for exercising your dog, parking and/or training. These areas will be marked with signs. Exhibitors to clean up after their dogs on all of Fifth Industrial Ct.

All trash is to be placed in proper receptacles. No unsupervised children allowed on or about the premises. Exhibitors dogs only allowed in the facility; no spectator s dogs. No consumption of alcoholic beverages.

FRIDAY 4-24C - Class Order: Premier JWW, Master/Exc JWW, Open JWW, Novice JWW, Time 2 Beat, Premier Standard, Master/Exc Standard, Open Standard, Novice Standard

SATURDAY 24C-4 – Class Order: Master/Exc FAST, Open FAST, Novice FAST (**FAST WILL BE ONE CLASS FOR ALL LEVELS**), Master/Exc Standard, Open Standard, Novice Standard, Master/Exc JWW, Open JWW, Novice JWW

SUNDAY 4-24C - Class Order: Master/Exc JWW, Open JWW, Novice JWW, Time 2 Beat, Master/Exc Standard, Open Standard, Novice Std

WALK THRU: FRIDAY - M/E JWW & STD: 4,8 & 12 walk/run, 16, 20 & 24 walk/run

All other classes - all walk then run

SATURDAY - M/E JWW & STD: 24, 20 & 16 walk/run, 12,8 & 4 walk/run.

FAST – ONE briefing M/E walk followed by Open/Novice FAST walk/run/run, Open & Novice STD/JWW Classes - all walk & run

SUNDAY - M/E JWW & STD: 4, 8 & 12 walk/run, 16, 20 & 24 walk/run, T2B, Open & Novice all classes will have one walk each class and run.

MEASURING: **There will be no VMO at this trial.** Each dog must have an official Jump Height Card or a yellow Temporary Measuring Form prior to running any of the agility courses. Each dog 15 months to 2 years must have 1 Temporary Measuring form. If you do not have a permanent or temporary card your dog MUST be measured by the VMO prior to running. The measurement done before your first run will be effective through the weekend. It is the owners' responsibility to ensure their dog is measured prior to running and to run in the appropriate jump height.

MOVE-UPS: Move ups prior to a set of trials. Dogs shall be moved up to higher classes as the request of the owner, as a result of qualifying for a lower level agility trial provided that the request is made, in writing, to the Trial Secretary NO LATER THAN 6PM on **Monday August 26th, 2019**. Move-ups can be emailed to bebedoyon@gmail.com. Dogs qualifying for a higher class by earning a title on Friday and Saturday may be moved up the following day provided the request is received, in writing, before the end of the first day trial. All correspondence will be acknowledged with a receipt of all move-ups and corrections to entries.

DIRECTIONS: Doggie U K9 Academy 1515 Fifth Industrial Court Bay Shore, NY 11706
From Southern State Pkwy - Exit 42 North - 5th Avenue - Bay Shore. Merge immediately to the left onto 5th Avenue ***Turn left onto Spur Drive North (McDonalds on the corner). Make first right onto 5th Industrial Court. Doggie U is on the left. You will see a sign for Master Concepts which is in the same building. Spur Drive North is just slightly north of Southern State Parkway.

From Sunrise Hwy - Exit 43 North - 5th Avenue. Follow from ***. From the LIE - Exit 53 - Sagtikos Pkwy to Southern State Pkwy East - Exit 42 North. Follow from ***.

Alternate route for commercial or large vehicles - LIE Exit 53 to Wicks Road. Travel 3.8 miles South on Wicks Road which becomes 5th Avenue. Right on Spur Drive North. Right onto 5th Industrial Court.
