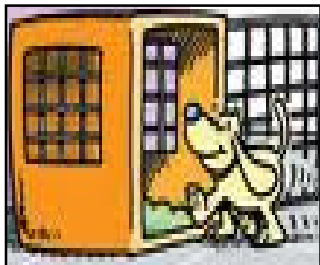

Please see attached summary report for class run counts. Please note this is a preliminary judging schedule which is contingent on move-up entries not yet received.

SETUP & SITE REGULATIONS



Doggie U will open at 7am on Saturday & Sunday for set up.

CRATING space is VERY limited. X-Pens are not allowed. Crating in the lobby and small crating room off the lobby. Crates to be stacked when possible. There is no floor space for crates for unentered dogs. ***Dogs must be in crates at all times except when in ring or at practice jump.*** No exhibitor chairs - facility has chairs available.

Chairs allowed in crating area if there is sufficient room for all crates.

Aisles must be clear at all times as per Fire Department regulations.

POTTY AREA is grassy strip in front of building & pebble stone potty area in front of loading bay. ***Neighboring complexes are not to be used for exercising your dog, parking and/or training. Any exhibitor in violation of this rule will be asked to leave the trial site. In such case, no refund of any fees paid will be made.***

THKC thanks all for their cooperation

PARKING No general exhibitor parking in small lot immediately in front of the building or in front of bay doors & dumpster or area on the street in front of the building. These areas are reserved for trial officials, handicap parking and exhibitors working out of their car. Please email Barbara Kennedy - barbarakennedynyc@gmail.com - if you are working out of your car. **PLEASE OBSERVE SIGNS FOR RESERVED SPACES.** Parking is allowed along the street and in the lot in front of and around the MasterCraft building. **PARKING IS NO LONGER ALLOWED IN CMS PARKING LOT. VIOLATORS WILL BE TOWED.** NO RV/camper or overnight parking available. Be aware - building north of DU has a guard dog.

MEASURING: There will not be a VMO at this trial.

Each dog must have an official Jump Height Card OR a yellow Temporary Measurement Form prior to running any agility courses. Each dog 15 months to 2 years old must have permanent AKC Jump Height card or 1 Temporary Measurement form. Each dog 2 years of age or older must have an official jump height card or 2 yellow Temporary Measurement Forms (measurements done at 2 years of age or older) If you do not have the required official measurement card or temporary form(s), your dog MUST be measured by one of the judges prior to running. The measurement done before your first run will be effective for the rest of the weekend. It is the owner's responsibility to have his/her dog measured prior to running the courses. **MEASURING** will take place approximately 30 minutes prior to briefing and walk-thrus for each class.

MOVE-UPS

Move-ups prior to a set of trials. Dogs shall be moved up to higher class at the request of the owner, as a result of qualifying for agility title, provided that the request is made in writing to Trial Secretary

no later than 6:00 p.m. on Monday, March 12th, 2018.

Dogs who qualify for higher class by earning a title on Friday or Saturday may be moved up for the following day if the request is received in writing before end of that day's trial. All correspondence will be answered and acknowledgement sent of receipt of all move-ups and corrections to entries.

WAIT LISTS

To fill openings created by entries withdrawn prior to date & time established by the club. Such date may be beyond the event closing date; however, it must be minimum of three (3) days prior to first trial date of the set of trials. All entries must be received prior to closing date and time. The club must establish maximum number of entries that may be placed on wait list. Whether club is offering a wait list, how many entries are being accepted on the wait list and closing date/time of wait list must be published in trial's premium list. A full refund is to be reimbursed to any entrant whose entry is replaced by wait-listed entry

From Southern State Pkwy - Exit 42 North - 5th Avenue - Bay Shore. Merge immediately to the left onto 5th Avenue. ***Turn left onto Spur Drive North (McDonalds on the corner). Make first right onto 5th Industrial Court. Doggie U is on the left. You will see a sign for Master Concepts which is in the same building. Spur Drive North is just slightly north of Southern State Parkway.

From Sunrise Hwy - Exit 43 North - 5th Avenue. Follow from ***.

From the LIE - Exit 53 - Sagtikos Pkwy to Southern State Pkwy East - Exit 42 North. Follow from ***.

Alternate route for commercial or large vehicles - LIE Exit 53 to Wicks Road. Travel 3.8 miles South on Wicks Road which becomes 5th Avenue. Right on Spur Drive North. Right onto 5th Industrial Court.
