Each dog 15 months to 2 years must have 1 Temporary Measuring form. If you do not have a permanent or temporary card your dog MUST be measured by the VMO prior to running. The measurement done before your first run will be effective through the weekend. It is the owners' responsibility to ensure their dog is measured prior to running and to run in the appropriate jump height.
