**CLASS ORDER:** Friday: 24C- 4 – Trial #1 FAST M/O/N, Trial #2 FAST M/O/N, Master/Exc Std, Open Std, Novice Std, Master/Exc Jww, Open Jww and Novice Jww

## WALK THROUGHS GROUPS:

**All Master Standard/Ex JWW**, 24- 20 (one walk) 16-4 walk/run (2 – walks will be split) walk/walk then run, run

**OPEN Standard and JWW:** All heights will walk, run

**Novice Standard and JWW:** All heights will walk, run

**T2B** All Heights will walk, run

**FAST** 24--4 walk, then run

**MEASURING: PAM STURTZ IS A VMO.** Each dog must have an official Jump Height Card or a yellow Temporary Measuring Form prior to running any of the agility courses. Each dog 15 months to 2 years must have 1 Temporary Measuring form. If you do not have a permanent or temporary card your dog **MUST** be measured by the VMO prior to running. The measurement done before your first run will be effective throughout the weekend. It is the owners' responsibility to ensure their dog is measured prior to running and to run at the appropriate jump height.

**MOVE-UPS:** Move ups prior to a set of trials. Dogs shall be moved up to higher classes as the request of the owner, as a result of qualifying for a lower-level agility trial provided that the request is made, in writing, to the Trial Secretary **NO LATER THAN 6PM on Monday June 23, 2025**. Move-ups can be emailed to bebedoyon@gmail.com. Dogs qualifying for a higher class by earning a title on Saturday may be moved up the following day provided the request is received, in writing, before the end of the first day trial. All correspondence will be acknowledged with receipt of all move-ups and corrections to entries.

**FROM THE SOUTH /*Nashua*** Everett TPK North to Manchester I-293/101 West. Follow signs toward Rt.101 West (Bedford/Milford). AK9C is located on Rt. 101 approximately 6 miles from the Rt. 114 interchange. AK9C is on the right across from Camp Rd at the blinking light.

**FROM THE SOUTH /*Boston*** North to Manchester I-293/101 West. Follow signs toward Rt.101 West (Bedford/Milford). AK9C is located on Rt. 101 approximately 6 miles from the Rt. 114 interchange. AK9C is on the right across from Camp Rd at the blinking light.

**FROM THE EAST COAST/*Boston*** West toward Bedford/Milford. AK9C is located on Rt. 101 approximately 6 miles from the Rt. 114 interchange. AK9C is on the right across from Camp Rd at the blinking light.

**FROM THE WEST** East toward Manchester/Bedford. Watch Salzburg Square Shopping Complex. AK9C is approximately 1 mile on the left after Salzburg Square at the blinking light across from Camp Road.

From I-293 South:

Take Exit 2 (Brown Ave) From the exit ramp, turn right onto Brown Ave, heading towards Manchester Airport. Proceed approximately 0.9 miles. Directly after the intersection of Brown Ave and Goff's Falls Rd, 2743 Brown Ave is the first turn on the left

From I-293 North:

Take Exit 2 (Brown Ave) From the exit ramp, Turn Left onto Brown Ave. Follow directions above

From RT 101East:

Merge onto I-293N/RT 101W heading towards Manchester Airport/Manchester/Bedford. Take Exit 2 (Brown Ave). Turn left onto Brown Ave and follow directions per the above

From RT 101West:

Merge onto I-293S/RT 101 E heading towards Manchester. Take exit 2 and turn right onto Brown Ave and follow directions from the above.
