**WALK THRU:** Briefings and walk–thru’s for each class will occur in the normal fashion. Please be aware that the briefing and walk–thru’s

Prem STD & Prem JWW will Walk/Walk and Run  
M/EX Std & JWW 24/20 Walk Run. 16, 12/8/4 will Walk/Walk/Run  
All Open/Novice STND/JWW all walk run.

T2B 4-16 Walk, then 20-24 Walk, then Run/Run

The club may change the running order and walk thru’s during the trial.

**MEASURING: Mark Giles is not VMO** Each dog must have an official Jump Height Card or a yellow Temporary Measuring Form prior to running any of the agility courses. Each dog 15 months to 2 years must have 1 Temporary Measuring form. If you do not have a permanent or temporary card your dog MUST be measured by the **JUDGE** prior to running. The measurement done before your first run will be effective through the weekend. It is the owners’ responsibility to ensure their dog is measured prior to running and to run in the appropriate jump height.

**MOVE-UPS:** Move ups prior to a set of trials. Dogs shall be moved up to higher classes as the request of the owner, because of qualifying for a lower-level agility trial provided that the request is made, in writing, to the Trial Secretary **NO LATER THAN 6PM on Monday June 23, 2025.** Move-ups can be emailed to bebedoyon@gmail.com. Dogs qualifying for a higher class by earning a title on Saturday may be moved up the following day provided the request is received, in writing, before the end of the first day trial. All correspondence will be acknowledged with a receipt of all move-ups and corrections to entries.

**DIRECTIONS:** Trial Site: **The Fieldhouse 15 Augur Road, Northford, CT 06472**

FROM RT. 91 SOUTH: Take Exit 14 for East Center Street toward CT150/Wallingford. Turn left on East Center Street. Turn right onto Northford Road and continue onto Woods Hill Road. Turn right onto CT-17 South. Continue onto CT-22 East. Turn right on Augur Road. FROM RT. 91 NORTH: Take Exit 9 to Montowese Avenue. Turn right on Montowese Avenue. Take slight left on Middletown Avenue. Turn right onto Half Mile Road and continue onto Augur Road Extension. Turn left on Totoket Road. Turn right on Augur Road.
