MEASURING: David Nauer is a VMOs There will be a VMO for this trial. Each dog must have an official Jump Height Card or a yellow Temporary Measuring Form prior to running any of the agility courses. Each dog 15 months to 2 years must have 1 Temporary Measuring form. If you do not have a permanent or temporary card your dog **MUST**, be measured by the judge prior to running. The measurement done before your first run will be effective throughout the weekend. It is the owners' responsibility to ensure their dog is measured prior to running and to run in the appropriate jump height.
