MEASURING: Frank Gilmer is NOT a VMO There will not be a VMO for this trial. Each dog must have an official Jump Height Card or a yellow Temporary Measuring Form prior to running any of the agility courses. Each dog between 15 months to 2 years must have 1 Temporary Measuring form. If you do not have a permanent or temporary card your dog MUST be measured by the Judge prior to running. The measurement done before your first run will be effective throughout the weekend. It is the owners' responsibility to ensure their dog is measured prior to running and to run in the appropriate jump height.

MOVE-UPS: Move ups prior to a set of trials. Dogs shall be moved up to higher classes as the request of the owner, because of qualifying for a lower-level agility trial provided that the request is made, in writing, to the Trial

Secretary no later than 6pm on **Monday August 19, 2026, at 6pm.** Move-ups can be emailed to bebedoyon@gmail.com. Dogs qualifying for a higher class by earning a title on Saturday may be moved up the following day provided the request is received, in writing, before the end of the first day trial. All correspondence will be acknowledged with a receipt of all move-ups and corrections to entries.

DIRECTIONS: Trial Site: **Dream Dogs Training Center**

From the South (NYC and New Jersey): I-87 North (NYS Thruway) to Saugerties Exit 20, then right onto Route 212 East, then right onto Kings Highway for 3 miles, then right onto Industrial Drive. Dream Dogs Training Center is on the left. Cars keep to the right when entering.

From the North (Albany and Western Massachusetts) I-87 South (NYS Thruway) to Saugerties Exit 20. Turn left onto Route 32 South, then turn left onto Route 212 East, then turn right onto Kings Highway. Follow for 3 miles, then turn right onto Industrial Drive and follow to the end.

From the East: Take the Kingston Rhinecliff Bridge/Route 199 then exit onto Route 9W North for 4.5 miles then turn left onto Glasco Turnpike and follow over the RR tracks then turn right onto Kings Highway. Then prepare to quickly turn left onto Industrial Drive, follow to the end of the road
